- 2. Invoices shall be raised in respect of sale.
- 3. Claims must me made within 24 hours of receiving order (quoting invoice number)
- **4.** Due notice of changes in prices and charges shall be issued however ROCKET FOODS reserves the right to make reasonable alterations to prices without notice.
- **5.** Payment is due 14 days on Direct Debit form date of Statement. I/We undertake to pay all accounts in full on or before due date or by Direct Debit.
- **6.** Overdue Accounts: ROCKET FOODS reserves the right to make a penalty interest charge of 2% per month on the overdue amount if payment is not received by the due date, and to charge costs of recovery and collection by our debit collection agency. Where payment is overdue, future orders may be held until such time as the account is current.
- **7.** Privacy Act 1993: ROCKET FOODS retains the right under the act to request information on credit customers from credit agencies or other referees and in the case of debtors who fail to meet their obligation to provide details of debtors and their debts to our debt collection agents. Any change in ownership of the applicant's business shall be promptly notified to ROCKET FOODS.
- **8.** Delivery will commence once credit application and personal guarantee forms have been completed and accepted by ROCKET FOODS.
- **9.** Product will be delivered early morning unless by prior arrangement. We will require a key and alarm code if these are necessary for entry or a safe place for delivery. Every care is always taken to ensure the security of your premises no liability is accepted by ROCKET FOODS and your agreement to these terms absolves ROCKET FOODS LTD of any or all liability that may arise.
- **10.** ROCKET FOODS cannot accept responsibility for goods that are delivered to an unsecured nominated site once they have been dropped off.
- **11.** Daily deliveries within central Auckland are free of a freight charge when over \$80.00 or a \$8.90 per order freight charge if under \$80.00 exclusive of GST.
- **12.** Daily deliveries outside of central Auckland areas outside of central Auckland may require a delivery fee depending on quantity needed and delivery location.
- **13.** Customers are not to act as a wholesale agent and, on-sell whole cakes to a third party without the consent from ROCKET FOODS.
- **14.** Any damaged or missing goods must be communicated to ROCKET FOODS on the day of delivery.
- 15. All prices quoted are exclusive of GST.
